## GENERAL INFORMATION

**PORT CHARGES** - Port charges are included in the rates. Taxes & fees are not included and are an additional \$83.86 per person for September 3; \$51.35 per person for October 7; \$70.37 per person for October 25; \$68.88 per person for November 16; \$68.58 per person for December 8; \$92.73 per person for December 19 and \$63.44 per person for January 3, 2011. Port charges, taxes and fees are subject to increase without notice.

**RESERVATIONS** - A 25% cruise fare per person deposit is due at time of booking. The balance is due 125 days prior to sailing along with a completed guest registration form.

**PAYMENTS** - The deposit and final payment may be charged to your major credit card. If paying by check, please make check payable to Klein Transportation.

**SINGLE, 3<sup>RD</sup>/4<sup>TH</sup> PERSON RATES** - Single, 3<sup>rd</sup>/4<sup>th</sup> person rates are available. Ask your Travel Consultant for availability and rates.

**ADDITIONAL INFORMATION** - A full description of Cunard's terms and conditions is located in the Cunard Queen Mary 2 brochure, available at Klein Transportation. Direct any questions to your travel consultant.

**PROOF OF CITIZENSHIP** - The U.S. Department of State Homeland Security requires all travelers to be in possession of a VALID PASSPORT, for all travel to the Caribbean & Canada.

**TRAVEL INSURANCE** - Trip cancellation insurance is for the reimbursement of all cancellation penalties. This coverage applies when certificated illness prevents travel. This insurance should be seriously considered by all clients as all cancellations regardless of cause are subject to penalties. See your Travel consultant for more details.

**CANCELLATION & REFUNDS** - Cancellation penalty is \$25 per person for administrative costs. In addition, Cunard's penalties per person are as follows:

**90 to 61 Days: 25% of full fare**

**60 to 31 Days: 50% of full fare**

**30 to 15 Days: 75% of full fare**

**14 Days or Less: No Refund**

**No Shows: No Refund**

The above cancellation penalties apply to all travel including cruise, airfare and land arrangements.
